#### President's Items

##### **3. Sponsorships**

There are 2 sponsors interested in facilitating a study-space kind of event.

The 1Ls should message Jamie with potential dates for a studying event in the JCR. We would want to have as many upper years there as possible to provide the 1Ls with advice. We will also provide snacks.

Hamza can contact the clubs for an event in the JCR.

A separate meeting will be held to discuss logistics of all the above.

We have a sponsor with Lax O'Sullivan for a separate wine and charcuterie night in the JCR.

## 2L Rep's Items

### 4. Levy Increase Protesting

Our view is that the levy increase is ultimately up to the student body.

If they choose to vote no once they have the information about all the services that would need to be cut, that's their decision.

This year, the clubs collectively asked us for 64k when we only have 15k to distribute, for instance.

So - the clubs cannot provide the events that they want to provide because we have no funding to give them.

That is going to be the outcome students are facing if the levy is not increased.

Reminder: the levy has not increased in 20+ years.

## Secretary's Items

### 5. Confirming that the 1Ls all have access to their L&L section rep emails now.

All of the 1Ls (except for Jasmine who had to leave because of another meeting) confirmed that they have accessed their L&L rep emails.

Kelly will discuss with Jasmine over messenger to confirm that she has access to her email.
